Dear friends!

More than 100 activists from 13 cities in a well-mixed composition came together at the germanwide meeting of We'll Come United (WCU) in Frankfurt at the beginning of February. How can the network, which we have built up in the last two years, be further developed and especially the self-organized structures be strengthened? How can we transmit our gained visibility into more efficient struggles against the deportation regime? What role will WCU play as a germanwide player in the Anti-Ra movement and what new alliances will it seek? What priorities will be set in future mobilizations? Along these questions WCU has set the first course for 2019 and agreed on swarming and mobilisation in Saxony this summer. The upcoming state elections on September 1 will lead us to expect an increased polarization of society. The "indivisible" alliance will mobilise to Saxony on 24 August, groups of the "NSU Tribunal" are planning a tribunal in Chemnitz for the weekend before. WCU

wants to take part and be at the start with parade elements on 24.8 in Dresden. Continuously - "against the whole right racist shit!" - local structures and activists in camps and communities should be visited, supported and encouraged.



More than 40 activists from Spain, Italy, Tunisia, Belgium, France, Switzerland and Germany came together at the transnational meeting of the so-called "Palermo Charter Process" in Barcelona at the end of February. Almost all sea rescue organisations, the Alarm Phone, Welcome

to Europe, Seebrücken and representatives of progressive city administrations participated. How can the (re)opening of ports be enforced and sea rescue decriminalised? Is there a need for a civilian rescue centre because the MRCCs (Maritime Rescue and Coordination Centres) in Rome and Valetta have become collaborators of the deadly border regime? How can refugees and rescued persons stuck in Southern Europe be assisted in transit to desired destinations in North-West Europe? How can we imagine "Buses of Hope", for example, from Palermo to Düsseldorf or Berlin? How to proceed in and with the Solidarity Cities? These were the key questions in Barcelona, which are now being discussed in transnational working groups with a view to practical implementation.



A small delegation of the meeting visited "Top Manta" afterwards. This is the name of a self-organised project, especially of Senegalese street vendors in Barcelona, who - started in 2015 as a grassroots

trade union initiative against expulsion and illegalisation - now run their own shop for T-shirts and hoodies. With "Top Manta" - "on the top of a blanket" - they have created their own brand: with an

In this sense, with solidarity greetings, the Compass Crew

expressive logo that simultaneously symbolizes their arrival with boats (Pateras) as well as their survival strategy as street vendors.



From Frankfurt to Barcelona, from local to transnational, against exclusion and deportation in the cities as well as against left-to-die and pushbacks on the sea: we will remain persistent in and with the flight and migration movements that drive the everyday struggles for freedom of movement and equal rights for all.

In the preparatory hand out for the meeting in Barcelona, it was formulated as follows: '...It is difficult for us to assess how things will continue in the Mediterranean and the EU over the next few months and next summer. In any case, we have to continue and better coordinate our initiatives to strengthen collective forms of transnational resistance. ... We now need concrete practices 'für Corridors of solidarity` from the Sea to the Cities ...'

### Call from Women in Exile

8th March International Women's Day is a global day remembering the historical, cultural, and political achievements of women. We celebrate 100 years of Women fights because we are the mothers, we are the family caretakers, domestic workers, babysitters, cleaners. We refugee women we are teachers, nurses, business women, engineers, this and all other talents are not put into consideration because we are isolated and discriminated. In 2019 we join the global call for a women's strike because we come united to make visible women's work in all aspects of life, inside and outside the house, in urban and rural areas, paid or unpaid no matter the color of our skin or our origins. Time is now to build a feminism which is inclusive and inter-sectional, a feminism that listens to all women\* and that ends with racist, sexist and discriminatory structures. We cannot succeed if part of us are held back, as refugee women\* we are double discriminated and we'll continue denouncing racists laws, the existence of lagers and deportation policies. Our aim is to enable refugees who identifying themselves as women\* to stand up for their rights as women\* living in this society. ### 14.3. in Ellwangen: Solidarity manifestation for refugees legal actions against their penalty orders

Refugees will sue against their warrants.

"Let us not allow a legitimate protest by refugees to be further criminalised at the Ellwangen State First Reception Centre.

Police operation in Ellwangen on 3 May 2018 called fundamental and human rights into question; refugees take legal action against their orders of punishment

Trial on Thursday, March 14, 2019 at 9.00 a.m. and 2.00 p.m. \* District Court Ellwangen  
 Mahnwache 11 a.m. - 6 p.m. and rally from 3.30 p.m. \* Am Fuchseck

... Ellwangen has become a symbol of our protest. We must not allow government agencies, a political prosecutor's office, political parties, racist Ellwangen hysteria or undifferentiated press coverage to further shift the rights of refugees to their detriment. The



fundamental issue here is the defence of fundamental and human rights. Laws such as the "Ordered Return Law" must not come into force. The attacks on the 'inviolability of the home' must be condemned with all clarity. All proceedings in connection with the police operation in Ellwangen must be stopped immediately. ... On 14 March, there are two further trials based on appeals against penalty orders. Show solidarity, come to court proceedings on 14 March 2019. #### **Protest - Actions - Art, Stop Racial Profiling!**

For many people, police violence means daily supposedly "suspicion-independent" police checks, inappropriate pocket checks and searches in public spaces, expulsions and public humiliation. It is obvious that the police use appearance and skin color to decide who they control. The controls are often only the starting point for further violence, which often ends fatally. For black people, people of color, migrants\*, Roma, poor and homeless people, sex workers\*, many queers and trans\* persons, these experiences are everyday experiences. That is racism!

#### **"Dangerous places"?!**

Especially busy inner-city areas such as Konstablerwache, Hauptwache or the railway station district become dangerous places for many people, as they are often picked out of the crowd, exposed, isolated and controlled by highly armed policewomen\*. Ironically, the police use the very term "dangerous places" as a basis for their so-called "suspicious"

controls. One can only guess which places the police classify as dangerous, because they are silent about them. That is why we say: Abolish "dangerous places"!



### **Individual cases? Institutional racism!**

In the course of the investigations into the so-called "NSU 2.0", which are closely related to the police station 1 in Frankfurt, there is often talk of "individual cases" of racist policewomen\*. That is a much too limited approach! Institutional racism is firmly anchored in the way laws are formulated and applied and how the profession of policeman works. We protest against this!

### **Remember the victims of police violence**

You are not forgotten. We name their names. Remembrance is not only important for Communities of Color but for society as a whole. Remembering means fighting!

### **Whose safety?**

We want to talk and think about alternatives to police. Because the police promise security, but for many they represent the exact opposite: Violence and threat. Thus it does not stand for the preservation, but the threat of a society of many. Let us stand up for a society in which justice and security are not created by violence!

### **Where injustice happens, there is resistance!**

Be it the 'Initiative in Remembrance of Oury Jalloh', the 'Campaign for Victims of Racist Police Violence', the organisation of refugees against the racist border regime or the 'Initiative Schwarzer Menschen in Deutschland'. We are here!

We demand from the state:

- An end to all racist police controls - A labelling obligation for policewomen always and everywhere - A systematic confrontation with institutional and everyday racism in police, justice and other state authorities - The introduction of independent investigative and control bodies coordinated by the affected communities - The abolition of the „Verfassungsschutz“.

We call on civil society:

- To assume joint responsibility - To observe the police critically and to oppose racist actions, whether in the district, on the train, on the street, at school or at work.

## Alarm Phone Report Februar 2019

"I don't need to be on the news, I need to be rescued" - these were the words of one of the precarious passengers who called us from the Central Mediterranean Sea on the 20th of January 2018. He was among a group of roughly 100 people who had left Libya a day before and made it into international waters before being refouled back to Libya by a cargo vessel - a refoulement ordered by the Italian authorities, even by the Italian prime minister Conte himself, and carried out by their Libyan allies together with a private merchant vessel. [...] In light of the devastation and suffering in all three Mediterranean regions, it is often difficult to remain hopeful and to struggle on. However, that thousands of people still make it across the sea in these very adverse circumstances gives evidence to the unrelenting desire to localise new routes and methods to reach a place of perceived freedom and security. Now European societies have to show solidarity, pressurise governments against their anti-migrant policies, and open corridors on which people can move to desired destinations after reaching the shores of Europe.

## Text recommendations

### Alarm Phone Sahara Text by Afrique Europe Interact

Another meeting of Alarmphone Sahara - a sister project of Watch The Med Alarmphone - took place in Agadez in mid-February. In a long report, Olaf Bernau of Afrique-Europe-Interact not only describes the situation of migrants\* and refugees in transit countries like Niger. Rather, it also deals with the context of society as a whole - including general security issues in the Sahel and the Sahara (not least in the context of Islamist terrorism), the situation in the city of Agadez (since EU migration policy has fundamentally changed the conditions for migrants in Niger), gender aspects, the almost 1,000-kilometre bus journey from Niamey to Agadez, comparisons between Mali and Niger, etc.

#### Solidarity Cities in Europe. Urban Politics between Charity and Citizenship

"In Europe, the movements of the cities of welcome, refuge and solidarity are growing. Civil society groups, urban politicians\* and city administrations are thus resisting the growing restrictions of European and national border and migration policies. At the same time, they are developing concrete local policies to protect or socially include people with precarious residence status. Last but not least, they form discursive antitheses to the Europe-wide rise of right-wing parties, which promote the sealing off of borders and the criminalisation of migrants.



The debates in politics and civil society initiated here also show the growing interest of left-wing actors in Europe in experiences and ideas from other "cities of solidarity". However, the administrative and political preconditions as well as the actors involved, the priorities and the approaches to action are different. In other words, there is no uniform concept of a solidary city. The differences begin with the diversity of migrant communities and refugee groups in the individual cities. They continue with the questions of who is responsible for what at the municipal level, such as the role of the police and the competences of the cities. Or: What are the possibilities for municipal influence and decision-making? What are the conditions for residence and migration? How is access to welfare state services regulated? These questions have already been solved differently within Germany, and there are even greater differences in comparison with other European countries. However, studies that look at these differences (and similarities) from an international comparative perspective and on an empirical basis do not yet exist. This brochure is therefore intended to help close this knowledge and research gap..."

## Circular: In which society do we want to live?!

„There is quite a lot on the move: On March 8, women's groups in Germany will take up the impulse from Spain and other countries for a women's\*/feminist strike and combine it with their debates on Care Revolution. On 15 March, the pupils movement "Fridays for Future" is calling for a big international climate strike day and it is foreseeable that thousands will not go to school on this day in many cities, but will take the streets. On 6 April, a germanwide demonstration against „rent madness“ (much too expensive rents) will be mobilised in Berlin. In the days before, action days will take place in many cities throughout Europe. Initiatives of the solidarity cities and the sea bridges discuss about "Buses of Hope", in which in spring refugees and rescued persons from Palermo or Naples travel in orange convoy in the direction of the receptive destination cities to northwest Europe. „Unteilbar“ and We'll Come United plan in the summer larger mobilizations in Saxonia - against the right shift and for the support of the local antiracist and anti-fascist networks. And if we expand our view to the south: on the African continent, different movements are currently taking to the streets in countries as diverse as Sudan, Togo, DR Congo and Cameroon against dictatorships, some of which are decades old. These various current examples of emancipative social protests give us hope, even if it is difficult to assess which sustainable dynamics will unfold from them. How do we fit into this dynamic?

With "In which society do we want to live?", we launched a new platform in January that consciously sees itself as a "slow" search process. As a cross-thematic and cross-spectrum initiative, we cannot and do not (yet) want to intervene in the current mobilisations. As individual groups we are of course involved and these are precisely the



fields and spaces in which we move with our everyday struggles and to which we refer. But we have started this initiative in order to strive in the medium term (not only with this circular) to establish links and connections in the above-mentioned activities in order to



strengthen the perspective of a common movement and a comprehensive narrative of the various everyday struggles beyond the respective days of action and campaigns. This is and remains the central objective of our initiative.(...)

Our manifesto has received a number of new signatories and the enrichment process we were hoping for has already got off to a good start. Our platform is intended to bring together diverse perspectives from different spectrums. In this context, four new text contributions can now be found on the website: On Care Revolution, on the unconditional basic income, on the unemployed movement and on solidarity-based economic

activity. (...) A second circular is planned for June 2019 to report on the interim results, not least in view of the Bewegungsstiftung's strategy conference to be held in Berlin from 18 to 20 October. For us, this conference will be a central meeting point for exchange and should open up further perspectives for the initiative.

### NSU Monologues in Hamburg

"our struggles are changing this country and have already changed it," imran ayata said in the aftermath. and ibrahim arslan: "our longing is to tell you our stories, our pain."

nothing has been clarified. it has to go on: dissolve the nsu complex. for the scene of the crime in hamburg this means: finally an investigative committee/Untersuchungsausschuß! renaming of the schützenstraße as süleyman taşköprü-straße! no final stroke!“
