Deportation charters to Iraq, the justification of physical violence at the external borders, support for Meloni's "Albania camp" or considerations for the outsourcing of asylum procedures to Rwanda: the racist outbidding contest in a continuous loop. A disgusting chorus of agitation from almost all parties. This is immediately noticeable in countless "individual cases", when the worst racists in the immigration authorities feel encouraged and use their "discretionary pow-

While asylum and human rights are being attacked at various levels and from all political directions, the refugee and migration movements themselves are having a lasting assertiveness. The arrival figures in Italy and Germany, for example, are among the highest in recent decades. Almost 160,000 people will have made it to Italy from Tunisia and Libya by the end of 2023. This is - despite and against Meloni's post-fascist government - over 50% more than in the previous year and, after 2016, the highest number of arrivals ever in Italy. In October 2023 alone, there were over 30,000 new asylum applications in Germany, and in November there were even over 35,000. The total number will be well over 300,000 by the end of the year, also one of the record years.



"Acknowledging the strength of refugee movements, we must continue to build and expand infrastructures for freedom of movement as a central element." - "We need a new APO, an extra-parliamentary opposition that must be migrant and trans-Mediterranean." - "We should work on a two-year plan, at least until the next federal elections." - "We need to think

beyond refugee and human rights and connect more strongly with struggles around other social issues." - "We must take a clear stance against the prevailing discourse and yet somehow remain open to the centre." - "With We'll Come United, we are looking for new forms of mobilisation that make our everyday struggles more visible again."

These voices from germanwide Anti-Ra strategy debates in recent weeks are examples of some of the challenges and approaches that will be discussed further in various meetings and spaces in the coming months, not least at a conference that We'll Come United is planning for



the end of April in Frankfurt. We want to take up these discussions and mobilisations as best we can in our Kompass, to accompany them and to contribute to the AntiRa movement returning to more offensive moments in the new year.

14 DEC. IN SEVERAL CITIES GERMANWIDE DAY OF ACTION AGAINST IMMIGRATION AUTHORITIES

"Fight racism - abolish immigration authorities!" Under this motto, a germanwide day of action will take place on 14 December 2023. There will be protests and actions in front of the respective immigration authorities in cities including Bad Doberan, Eberswalde, Magdeburg, Leipzig, Göttingen, Osnabrück, Frankfurt Main, Cologne, Kiel, Eschwege, Kassel, Munich and Salzwedel...

NIGER: ANTI-MIGRATION LAW REPEALED

The summer of migration was not even over when Niger passed the 2015-36 anti-migration law in 2015 under pressure from the EU, which criminalised the previously completely legal services for migrants. The law never achieved its actual goal, because after a brief dip in numbers, by 2022 desert crossings had climbed back to the level they were at when the law came into force in September 2016. But the effects were still catastrophic: for the migrants, who were suddenly confronted with longer, more expensive and deadlier routes through the desert, for the service providers, thousands of whom lost their



livelihoods (and with them mostly families of 10 to 15 people) and for the migrant workers and long-distance traders within the West African region, who suddenly had major problems crossing borders to and from Niger. It is therefore all the greater that the transitional government in Niger, which emerged from a coup, retroactively repealed the law at the end of November (i.e. also rehabilita-

ted those convicted). In doing so, it has given in to the great social and civil society pressure in Niger, to which Alarme Phone Sahara, which emerged from Afrique-Europe-Interact, has also made an important contribution - among other things with a complaint to the Court of Justice of the West African Economic Community ECOWAS in Abuja (Nigeria).

EL HIBLU 3: SCANDALOUS BILL OF INDICTMENT, COMMENTS AND PROTESTS



"A Grave Injustice: Attorney General Files Bill of Indictment against the El Hiblu 3 Press Release from 30 November 2023 The Attorney General of Malta has issued a Bill of Indictment against Abdalla, Amara, and Kader, also known as the El Hiblu 3. They have been wrongly charged with a long list of serious crimes which could carry life imprisonment. We are aggrieved and angry that the Attorney General has ignored the testimonies heard during the compilation of evidence over the last four and a half years, which demonstrate the indisputable innocence of the El Hiblu 3. Instead, the Attorney General holds the three young men responsi-

ble for the general tension on board during and after rescue by the vessel El HIBLU 1. The Attorney General retained all the initial, unfounded charges, including the unsubstantiated charge of terrorism.

Let us not forget that Abdalla, Amara, and Kader helped calm a highly charged situation on board the ship. Let us not forget that, thanks to them, lives were saved. Thanks to them, people did not jump overboard. Thanks to them, no one was hurt. Thanks to them, any misunderstandings with the crew were addressed.

We are convinced that the El Hiblu 3 did the right thing: they helped diffuse a tense situation at sea and helped prevent an illegal pushback to Libya. Abdalla, Amara, and Kader are heroes, not criminals!

In charging the three young men, the Maltese authorities have missed an opportunity to rectify a grave injustice that has unfolded over nearly five years. Their actions should be celebrated, instead of being criminalised. With widespread support nationally and internationally, we will continue to stand in solidarity with Abdalla, Amara, and Kader until they are acquitted. Free the El Hiblu 3!

"On 11th of October 2023 an impressive commemorAction took place near the port of Lampedusa to remember the victims of the big shipwrecks ten years ago and at the same time to point out the responsibility of the European border regime in the ongoing death at sea that continues to this day. According to IOM figures, in 2023 another 2480 people died adding to the 17,000 deaths and disappearances recorded by MMP

since 2014. As safe passage was denied to people on the move, they were killed by a racist policy of migration control, determent, and externalization. We will never forget and never forgive those state border crimes while we continue our support for and our solidarity with all people on the move."



INVESTIGATIVE REPORT: FRONTEX, MALTA AND PUSH-BACKS TO LIBYA

"Frontex and the pirate ship

The EU's border agency Frontex and the Maltese government are systematically sharing coordinates of refugee boats trying to escape Libya with a vessel operated by a militia linked to Russia, human trafficking, war crimes and smuggling.

Tareq Bin Zeyad (TBZ) is one of the most dangerous militia groups in the world. It is run by Saddam Haftar, the powerful son of East Libyan warlord Khalifa Haftar. The group has been operating a vessel, also called TBZ, in the Central Mediterranean since May, during which it has intercepted more than 1,000 people at sea off the coasts of Libya and Malta and returned them to Libya....."

"At the Turkish-Bulgarian border, attempts by migrants to enter the EU often end in fatal exhaustion. The authorities bury the bodies quickly - without identifying them. This is a further trauma for the relatives. (...)

According to research by ARD's Vienna studio in cooperation with Lighthouse Reports, Der Spiegel, RFE/RL, Solomon and inews, at least 93 people have died on their journey through Bulgaria in the past two years alone..."

STOP GEAS DEMONSTRATION IN BERLIN ON 26.11.23



"In response to the planned tightening of asylum regulations in Germany and the historically most massive restriction of the Common European Asylum System (CEAS), thousands demonstrated throughout Germany today. Protests took place in 15 cities under the slogan "Stop GEAS - Asylum is a human right" - including Berlin, Bremen, Bielefeld, Dresden, Halle, Hanover, Cologne, Kiel, Mainz, Marburg, Nurem-

berg and Würzburg. Further protests are planned in Hamburg and Düsseldorf, among other places, in December. At the central demonstration in Berlin today alone, over 1,500 people took to the streets to demand a solidarity-based migration policy in the EU. The "Stop GEAS" campaign is calling on the EU Parliament to stop these historic cuts and to stand up for the human rights of all. The individual right to asylum must remain the foundation of our protection system.

The "Stop GEAS" campaign is also calling on the German government to comply with its election pledge to support a human rights-based migration policy and to vote against the reform.

At the beginning of December, a decision is to be made on a whole bundle of regulations as part of the EU trialogues. As a result, human rights violations would be legalised, the fundamental right to asylum in Europe would be de facto abolished and the crisis in European migration policy would be further exacerbated..."
